Judge and Route Setter Courses will be organized, certification level following the courses will be Continental level.

1. Format

Judges

- Dates: 2 July 3 July 2017
- Participants shall learn IFSC rules before the beginning of courses (https://www.ifsc-climbing.org/index.php/world-competition/officials-resources)
- Entry exam on IFSC rules
- Participants shall speak a fluent English
- During course, case study through examples will be proposed
- Then a practice during Asian Youth Championship competition
- IFSC Judge in several continental events + report on experience
- At least 2 experiences per disciplines within 3 years

Route Setters

- Dates: 30 June 4 July 2017
- Participants shall learn some IFSC rules before the beginning of courses (https://www.ifsc-climbing.org/index.php/world-competition/officials-resources)
- Participants shall speak English
- During course, route setting and test route will be proposed
- Then a practice during Asian Youth Championship competition
- Route Setter in several continental events + report on experience
- At least 2 experiences per disciplines within 3 years

2. Participation

Pre-requisite for participation:

- NF not having debt to the IFSC and / or ACC
- NF organizing on regular basis a National Championship
- Application shall be made by NF

- Applicant shall be certified National Judges
- Not less than two years judging experiences
- Could speak, read and write English
- Could perform lead climb belaying

Route Setters

- Applicant shall be certified National Route Setters
- Not less than three years route setting experiences in competition (not in climbing gym)
- Could speak English
- Understand competition rules
- Minimum climbing skill at V7-8/5.13D/8B
- 3. Quota of participant per course:

- Judges: 16

Route Setters: 12
